

## ROAD TRAFFIC REGULATION ACT 1984

### OXFORDSHIRE COUNTY COUNCIL (THE RIDGEWAY AND SWAN'S WAY – EWELME TO LEWK NOR) (PROHIBITION OF DRIVING) ORDER 200\*

The Oxfordshire County Council (“the Council”) in exercise of their powers under Sections 1 (2), 2 (1) and (2) and 22 (1) and (2) of the Road Traffic Regulation Act 1984 (“the Act”) and all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of schedule 9 to the Act, make the following Order: -

1. This Order shall come into operation on (*date when comes into operation*) and may be cited as the Oxfordshire County Council (The Ridgeway and Swan's Way – Ewelme to Lewknor) (Prohibition of Motor Vehicles) Order 200\*.
2. In this Order, except where the context otherwise requires, the following expressions have the following meanings -
  - (1) “Motor Vehicle” means a mechanically propelled vehicle, excluding an invalid carriage which complies with requirements prescribed by regulations and which is being used in accordance with conditions prescribed by regulations.
  - (2) “Restricted Period” means the period from 1 October of any and every year to 30 April of the following year, inclusive of both dates.
  - (3) “Way” means the length of highway known as Swan's Way on the highways and in the parishes specified in Part 1 of Schedule 1 to this Order and the adjoining length of highway known as The Ridgeway on the highways and in the parishes specified in Part 2 of Schedule 1 to this Order which together extend from the junction of Swan's Way with the unnamed road between Ewelme and Cookley Green (grid reference SU6659291408) in a north easterly direction for a distance of about 9.26 km to the junction of The Ridgeway with the A40 at The White House Lewknor (grid reference SU7280697699), but excluding any part of the highways listed in Schedule 2 to this Order. The expression ‘the Way’ includes each and every part of it.
3.
  - (1) Any reference in this Order to any enactment shall be construed as a reference to that enactment as amended or replaced by any subsequent enactment.
  - (2) Words importing the masculine gender shall also include the feminine gender and words in the singular include the plural and vice versa.
